



## **Petro-Points Auto Club Benefits**

**For members who signed up for Petro-Points Auto Club post Sept. 25, 2004.  
Benefit maximum of four (4) calls per membership year.**

### **Fuel Delivery (Gasoline)**

An emergency supply of gasoline (\$5) will be delivered to the Member free of charge to enable the Member to reach the nearest available gasoline retailer.

### **Battery Boosts or Cold Weather Starting**

If a Member's vehicle fails to start, **Petro-Points\*** Auto Club will dispatch a service provider in an attempt to start the Member's vehicle with a battery boost or other available means.

### **Tire Changes**

A Petro-Points Auto Club Service provider will install the Member's inflated and safely operable spare tire. In the event the spare tire is unusable, the vehicle will be towed to the nearest, qualified repair facility. Petro-Points Auto Club service providers do not repair tires on site.

### **Lockout Services**

If keys become locked in a member vehicle, a Petro-Points Auto Club service provider will attempt to unlock the vehicle by gaining access through the vehicle's passenger compartment only. Parts, excessive labour and/or services of a locksmith may be at the Member's expense.

### **Winching/Extrication**

A Member vehicle will be extricated/winched by a Petro-Points Auto Club Service Provider if and when it has become stuck in an area immediately adjacent to a regularly traveled road and can be safely reached with conventional automobile servicing equipment. A Petro-Points Auto Club registered vehicle is entitled to one (1) truck and one operator for up-to one (1) hour at the scene.

### **Towing**

Should a Member's vehicle not be able to continue operating safely under its own power following a mechanical breakdown, it will be towed to the nearest, qualified repair facility within 160 km as follows:

- a. Nearest Petro-Canada qualified service facility and authorized Petro-Canada service-bayed facility within 160 km of breakdown site; or
- b. Nearest independent qualified service facility within 160 km of breakdown site

### **Professional Legal Benefits**

Should the member be charged under the Highway Traffic Act, benefits would be paid up to amounts shown on the following schedule:

- a. Professional Legal Defense - up to a maximum of \$100
- b. Professional Legal Advise - up to a maximum of \$100
- c. Professional Representation at an Inquest - up to a maximum of \$300

### **Hazardous Weather Benefits**

Should a member vehicle experience delays and/or unplanned expenses due to snow, hail, ice, flood, tornado, hurricane, fog, avalanche or forest fire more than 250 km from home, benefits will be reimbursed for personal rescue, emergency accommodation, meals, emergency communications, personal necessities and essential non-medical expenses incurred during the first 48 hours immediately following the incident. Benefits are paid at 75% of actual expenses incurred, to a maximum combined total of \$250 per membership year. In order to qualify for this benefit, the highway being traveled must be declared closed to the Ministry of Transportation or local police or authorities. Proof must be submitted that roads were impassable, such as a police report, government report or newspaper clipping describing the circumstances and confirming the incident.

### **Stolen Vehicle Benefits**

Should a members vehicle be stolen, Petro-Points Auto Club will reimburse up to \$600 for information leading to the arrest and conviction of the guilty party.

### **Ambulance Reimbursement**

If ambulance services are required following an accident, the Member as driver will be reimbursed 100% of ambulance costs not covered by any provincial health plan or automobile insurance company.

### **Your Satisfaction is Guaranteed**

If for any reason, you are not completely satisfied with your Petro-Points Auto Club Membership, you are entitled to a full refund of your Membership fees (minus the cost of any services already provided) within the first 30 days of your Membership year. To receive a refund, you must apply in writing and return your Membership card.
